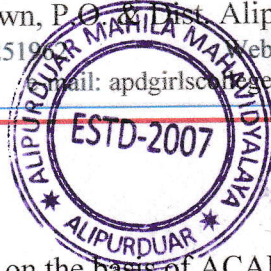

## ACTION TAKEN REPORT on the basis of ACADEMIC AUDIT, 2020 – 21

### Observations Made:

1. The institution should procure more books for the library, catering to the needs of the students. While providing textbooks to the students should remain the primary concern of the HEI, buying reference books for advanced learners should also be considered with equal priority.
2. There is ample scope in developing research activities in the institution. The administration should chalk out clear policies in creating an ecosystem of research that will encourage faculties to apply to external agencies for research projects or to write articles for peer reviewed journals.

### ACTION TAKEN

1. The total number of books in the library during the session 2020 – 21 was 4209. Based on the observation, a significant effort has been made to increase the number of books in the library. The total number of books as on 30/06/2022 is 4558.
2. A Research Cell has been created. The objective of the Cell is to motivate teachers to apply to different agencies for funds for research projects or seminars.

## ACTION TAKEN REPORT on the basis of ACADEMIC AUDIT, 2021 – 22

### Observations Made:
